The event is easily accessible to people from New York City, Philadelphia, Delaware and, of course, all the Jersey Shore towns.

Date & Time: Saturday 12:00 pm – 5:00 pm and Sunday 12:00 pm – 5:00 pm. *This event is held rain or shine and there is no rain date.*

Location: FirstEnergy Park's Great Lawn (immediate exterior of stadium)

Advertising: The event will be promoted in New Jersey Monthly magazine, local newspapers, localwineevents.com, street signs, Facebook, events page on BlueClaws.com, rack cards, posters, press releases, mobile application and more. We will also send you rack cards which we will ask you to distribute in your tasting room and ask that you list this event on your website.

Winery Participation:

1. Wineries must secure all necessary individual ABC permits and licenses to participate. Lakewood BlueClaws will secure all necessary event permits and licenses.
2. Lakewood BlueClaws will manage the Ticket Booth for the wine tasting and will provide patrons with a sampling glass and wristband for a nominal fee. This fee will be retained by Lakewood BlueClaws.
3. Wineries may sell wine by the bottle and case. Lakewood BlueClaws will NOT take any proceeds from these sales. Patrons may open bottles and consume on premises.
4. **Participation fee is \$250.** Lakewood BlueClaws will provide your tent set up (20' X 20' tent) plus four tables and two chairs.
5. **There are twelve winery spots. Please submit your application in a timely manner to secure your spot.**
6. Your featured wine list is due by May 1, 2018.

Event Logistics: Information regarding load in/out times, directions and parking will be distributed one month prior to the event.
